Speaker Resume's

James M. Van Nostrand is a Professor of Law and Director of the Center for Energy and Sustainable Development at West Virginia University College of Law. Before coming to WVU in July 2011, he spent three years as a member of the adjunct faculty at the Elisabeth Haub School of Law at Pace University in White Plains, NY and as Executive Director of the Pace Energy and Climate Center. For 22 years before this, he was in private practice representing energy clients in state regulatory proceedings in eight western states, as well as proceedings before the Federal Energy Regulatory Commission. He received his LL.M. in Environmental Law from the Elisabeth Haub School of Law at Pace University, his J.D. from the University of Iowa College of Law, a master's degree in economics from SUNY at Albany, and an undergraduate degree in economics from the University of Northern Iowa. He is the author of a book published by Cambridge University Press in July 2022 titled, *THE COAL TRAP: HOW WEST VIRGINIA WAS LEFT BEHIND IN THE CLEAN ENERGY REVOLUTION*.

Jennifer Walling has served as the Executive Director for the Illinois Environmental Council since January of 2011, where she oversees the strategic direction and management of the organization and lobbies decision makers on environmental issues. She has drafted, negotiated, lobbied and passed hundreds of bills in Springfield while working to build the power, expertise and relationships of the entire environmental community. She holds a bachelor's and a master's degree in Natural Resources and Environmental Sciences from the University of Illinois at Urbana-Champaign and a juris doctorate from the University of Illinois College of Law.

Howard A. Learner is an experienced public interest environmental and energy litigation attorney serving as Executive Director of the Environmental Law & Policy Center (ELPC), the Midwest's leading environmental legal advocacy and eco-business organization. He is responsible for overall strategic leadership, financial planning and program direction for the organization. ELPC is noted for its work promoting climate change solutions, clean energy development, innovative transportation policies, and protecting the Great Lakes and the Midwest's natural resources and heritage. One of ELPC's core premises is that environmental progress and economic development can be achieved together. Mr. Learner is also an Adjunct Professor at the University of Michigan Law School teaching advanced seminars on climate change and clean energy law, sustainable development and environmental constitutionalism. He received his J.D. from Harvard Law School, and his B.A. (Honors) from University of Michigan.
